Per NYS law, the following rules must be followed at every location:

- Masks must be worn over mouth and nose at any time you are standing.
- All wine consumption must take place while seated; masks can be removed once seated, but must be put back on at any time you get up- even to get more wine!
- All wine consumed on-site must be accompanied by a food purchase, which in most cases is built right into the tasting fee, or ala cart for a nominal fee.
- Social distancing is required when standing and moving about.
- Tables cannot be moved or rearranged, as they're spaced according to NYS law.

A few things to be cognizant of:

- See above to see who requires reservations. Those that don't, you may still be required to wait to get in as there are limitations on tasting room capacity and limited tables
- Each winery is operated differently, so you may get a different experience at each winery– diversity is a good thing!
- Because the tasting experience has been elevated, the tasting fees have also gone up. You can expect to see the average price between \$8 and \$12 dollars– trust me, the new open-air experience is well worth it!
- Food and alcohol from other locations is NOT permitted on any other property.
